- 1- The Islamic Republic of Pakistan has received financing from the Asian Development Bank (ADB) toward the cost of "National Disaster Risk Management Project" and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to bidders from eligible source countries of ADB.
- 2- The National Disaster Risk Management Fund (NDRMF) – a government-owned not-for-profit company incorporated with the Securities and Exchange Commission of Pakistan, under Section 42 of the Companies Act 2017 ("the Purchaser") invites sealed bids from eligible bidders for "Procurement, Supply & Installation of IT Hardware, Software Including Goods and Related Services" i.e. **Computer Power, Workstations & Desktops, Virtual Tape Library, Network & Security, Router, DC TOR Switches, Network Switches, WLAN Controller, Wireless Access Points, Video Wall, Smart Cabinet, Software, Plotter, Printer, Data Centre Tools, Connectivity**, as per the Quantities, Specifications and delivery Schedule mentioned in the Bidding Document. The national bidders should have valid NTN/STRN and placed on the Active Taxpayers List of FBR.
- 3- **National Competitive Bidding** will be conducted in accordance with ADB's **Single-Stage Two-Envelope** procedure and is open to all bidders from eligible countries as described in the Bidding Document.
