- 1. This Invitation to Bids follows the Procurement Notice (PN) or Procurement Advertisement (PA) No. 002/26/Proc-2 for the subject Project/Procurement which appeared in renowned national Dailies and published on Website of NDRMF & PPRA vide dated 22<sup>nd</sup> May, 2024.
- 2. The Procuring Agency has reserved the funds for the procurement planned during the financial years 2024-25. It is intended that part of the proceeds of the fund will be used to cover eligible payment under subject contract.
- 3. The National Disaster Risk Management Fund now invites sealed bids via PPRA EPAD System (<a href="www.eprocure.gov.pk">www.eprocure.gov.pk</a>) from eligible Insurance Companies having established office(s) at Islamabad, duly registered with SECP and relevant Tax Authorities, having minimum rating of "AA" from PACRA/JCS-VIS and fulfil eligibility and qualification requirements as mentioned in the bidding document.
- 4. The bidding shall be conducted in line with the *Single Stage One Envelope* procedure of the Public Procurement Rules 2004 and *Least Cost Selection* method as envisaged under Public Procurement Rules and Regulations, or Instructions as indicated in Standard Bidding Document issued by the Authority (from time to time), and is open to all potential bidders through PPRA EPAD System (<a href="https://www.eprocure.gov.pk">www.eprocure.gov.pk</a>).
- 5. All Bids must be accompanied by a **Bid Securing Declaration** on the format provided in the Bidding Document **Form 4**. ## SECTION II: INSTRUCTION TO BIDDERS (ITBs)

This Section provides information to help Bidders prepare their Bids. Information is also provided on the submission, opening, and evaluation of Bids and on the award of Contracts. Standard instructions remain the same as illustrated in PPRA National Standard Bidding Document for Procurement of General Goods.

These instructions are supplemented by Bid Data Sheet in following Section III.

	A. Introduction		
1. Scope of Bid	1.1	The Procuring Agency (PA), as indicated in the <b>Bid Data Sheet</b> (BDS) invites Bids for the provision of Insurance cover as specified in the BDS and <b>Section V – Schedule of Requirements, Scope of Service</b> . The successful Bidders will be expected to deliver the goods within the specified period and timeline(s) as stated in the <b>BDS</b> .	
2. Source of Funds	2.1	Source of funds is referred in Clause-2 of Invitation for Bids.	
3. Eligible Bidders	3.1	A Bidder may be natural person, company or firm or public or semi-public agency of Pakistan or any foreign country, or any combination of them with a formal existing agreement (on Judicial Papers) in the form of a joint venture, consortium, or association. In the case of a joint venture, consortium, or association, all members shall be jointly and severally liable for the execution of the Contract in accordance with the terms and conditions of the Contract. The joint venture, consortium, or association shall nominate a Lead Member as nominated in the BDS, who shall have the authority to conduct all business for and on behalf of any and all the members of the joint venture, consortium, or association during the Bidding process, and in case of award of contract, during the execution of contract.	
	3.2	The appointment of Lead Member in the joint venture, consortium, or association shall be confirmed by submission of a valid Power of Attorney to the Procuring Agency.	
	3.3	Verifiable copy of the agreement that forms a joint venture, consortium or association shall be required to be submitted as part of the Bid.	
	3.4	Any bid submitted by the joint venture, consortium or association shall indicate the part of proposed contract to be performed by each party and each party shall be evaluated (or post qualified if required) with respect to its contribution only, and the responsibilities of each party shall not be substantially altered without prior written approval of the Procuring Agency and in line with any instructions issued by the Authority.	
	3.5	The invitation for Bids is open to all prospective supplier, manufacturers or authorized agents/dealers subject to any provisions of incorporation or licensing by the respective national incorporating agency or statutory body established for that particular trade or business.
